INFLUENZA AND PNEUMOCOCCAL IMMUNIZATION REMINDER

Dear Adult Family Home Provider:

**We need your help to protect residents and staff from the flu and pneumonia this season.** Every year, about 100 to 1,000 Washington residents die from influenza or its complications with most deaths occurring among those 65 years or older.

**Create a safe and healthy environment for everyone. Minimize the impact of flu and pneumonia by:**

1. **Encouraging all residents and caregivers, without contraindications, to get vaccinated against flu and encouraging pneumococcal vaccination in those for whom it is indicated.** People can be vaccinated against flu at any given time of the year. Early fall, however, is the optimal time to receive the flu vaccine as it ensures protection before flu begins to circulate in our state. Several types of flu vaccine are available this season, and there is no preferential recommendation for one vaccine product over another in adults.

3. **Calling your local health department if you notice a sudden increase in acute respiratory illness (two or more ill residents within 72 hours) or when any resident tests positive for flu.** They can help with advice about testing, treatment, prophylaxis and infection control.
