CLARIFICATION OF WASHINGTON NAME AND DATE OF BIRTH BACKGROUND CHECKS AND NATIONAL FINGERPRINT-BASED BACKGROUND CHECK REQUIREMENTS

Dear Provider/Administrator:

This letter is to provide clarification on the Washington Name and Date of Birth (WNDOB) and national fingerprint-based background requirements.

Background check requirements are based on each regulatory authority's requirements. DSHS and DOH are not the same regulatory authority and each has its own regulatory requirements. DSHS requires background checks, including those on healthcare and long-term care personnel, to be conducted by the Background Check Central Unit (BCCU) using the BCCU background check authorization form and provide any additional documentation and any information requested by the department for background check through BCCU. This provision includes staff obtained through nursing pools and staffing agencies. In the case of staff obtained from nursing pools and staffing agencies, the CCRSS provider must submit the BCCU background check authorization and any additional documentation and information requested by BCCU before that staff is employed by the provider.

A Certified Community Residential Services and Support (CCRSS) licensee, employee, service provider, contractor, subcontractor, volunteer, student, intern, or any other individual who was hired on or after January 1, 2016 and who may work in a position that may have unsupervised access to a client must complete <u>both</u> a WNDOB and a national fingerprint-based background check by following all department and BCCU procedures.

Individuals <u>16 years old and over living in the home of a CCRSS companion home provider</u> authorized by DDCS to provide services to client(s) must complete <u>both</u> WNDOB and national fingerprint-based background check through BCCU.

Any applicant or service provider who has resided in Washington <u>less than three consecutive</u> <u>years</u> prior to the application must complete <u>both</u> the WNDOB and the national fingerprint-based background check through BCCU. Individuals who reside out of state but work in Washington also must have a national fingerprint-based background check.

The CCRSS provider <u>must</u> renew the WNDOB check for each administrator, employee, contractor, subcontractor, volunteer, and student at least every 36 months and keep current background check results for each.
