EMERGENCY RULES FILED TO AMEND LONG-TERM CARE WORKER

CONTINUING EDUCATION DEADLINES

Dear Provider/Administrator:

The Department of Social and Health Services (department) filed emergency rules under <u>WSR</u> <u>23-09-052</u> <u>amending</u> long-term care worker Basic Training deadlines established in WACs <u>388-71-0876</u> and <u>388-112A-0081</u>: When must long-term care workers who were working or hired during the COVID-19 public health emergency complete training, including required specialty training?

This amendment extends the Basic Training and Home Care Aide Certification deadlines for any Long-Term Care workers hired or rehired between 5/1/2021 and 06/30/2023.

The emergency rules SHS-4971.6 Final describe these new deadlines as below:

 Unless exempt from training as described in WAC 388-71-0839 or 388-112A-0090, a long-term care worker affected by the COVID-19 public health emergency must complete training, including required specialty training, as follows:

Worker hired or rehired during the time frame of:	Must complete basic training no later than:
8/17/2019 to 9/30/2020	1/31/2023
10/1/2020 to 4/30/2021	4/30/2023
5/1/2021 to 3/31/2022	7/31/2023
4/1/2022 to 9/30/2022	10/31/2023
10/1/2022 – 6/30/2023	11/30/2023
Beginning 7/1/2023	Standard training requirement of 120 days from hire date

(2) Unless exempt from certification as described in WAC 246-980-025, a worker affected by the COVID-19 public health emergency who is required to be certified as a home care aide must obtain certification as follows:

Worker hired or rehired during the time frame of:	Must be certified as a home care aide no later than:
8/17/2019 to 9/30/2020	5/31/2023
10/1/2020 to 4/30/2021	8/28/2023
5/1/2021 to 3/31/2022	11/27/2023
4/1/2022 to 9/30/2022	2/27/2024
06/30/2023	3/28/2024
Beginning 07/1/2023	Standard certification requirement of 200 days from hire date

The effective date of this emergency rule was April 17, 2023. The expiration date is August 15, 2023.
