ALTSA: NH #2014-021 REVISIONS TO RAI USER'S MANUAL

Dear Nursing Facility/Home Administrator:

This letter contains important information for facility staff responsible for completing the Minimum Data Set (MDS) assessments.

The Centers for Medicare and Medicaid Services (CMS) recently released updates to the Long-Term Care Facility Resident Assessment Instrument (RAI) User's Manual Version 3.0. Changes include updates and clarifications, some of which are minor "clean-ups" such as correcting spelling, the addition of new items and some substantive changes as well. Changes have occurred in Sections A, C, E, G, H, J, K, M, N, O, X and Z of Chapter 3. Portions of Chapters 1, 2, 5, 6 and Appendix H have edits. **The updates are effective October 1, 2014.**

The update includes "Track Changes" documents that describe the items in each chapter/section that have changed, the page number of the changes and the actual chapter/sections that have been changed. You may choose to download the entire chapters or only the pages where changes have occurred:
