STATE COUNCIL LIAISON-GOVERNOR'S OFFICE

Jason McGill, Policy Adviser & liaison to the Council, discussed the budget and reinvesting in WA State. Suggested the House and Senate may have difficulty with the listed investments.

Marilyn had a question about veterans affairs and sharing the burden of kinship care for military children.

*Accountable Care Organizations and related legislation. He provided an update on the status of legislation related to retirement savings, transportation, state Alzheimer's (dementia) Plan and policy related to being more forward looking about long term care insurance.

The Chair shared there is significant concern about people being able to access their long term care insurance and questionable delays in the process. Jason suggested that Gail provide him with more information and discussed involving the Office of the Insurance Commissioner.

Kathy Miller provided a brief overview of the Caregiver Forum that was held in Seattle this morning. Speakers included Trudee Inslee and many others, including the DSHS Secretary. One focus of the forum was that employers need to be more understanding about employee roles as caregivers.
