- **Page 103, under "Types of Abuse":** Updated definitions of sexual, physical, and mental abuse to match Washington Administrative Code to include intentional and reckless action or inactions.
- **Page 139, under "Tips for Assisting a Client to Walk":** Added guidance to stand slightly behind and to the side of the client to best support them if they become unsteady.
- **Page 140, under "Walkers":** Added guidance to never walk in front of a client who is using a walker. Stand behind or beside a client while you are assisting them to walk. Be especially careful in high-risk areas such as the bathroom and/or shower room.
- **Page 147, under "Decreasing Fall Risk": Added** guidance to stand slightly behind and to the side of the client to best support them if they become unsteady.
- **Page 166, under "Showers":** Added guidance that shower rooms and bathrooms are high-risk areas for falls. Stand behind or beside a client while you are assisting them to walk. Never walk in front of a client who is using a walker.
