#### **Background**

On April 2, 2015, the Court ordered the Department of Social and Health Services (DSHS) to file monthly reports with the *Trueblood* Court Monitor on efforts to comply with Court orders to provide timely competency evaluation and restoration services to Class Members:

"Defendants shall file a report with the Monitor on the fifth day of every month, which shall include:

- (1) the number of days between when a court ordered provision of competency services and when provision was completed, for each person ordered to receive competency services during the previous month;
- (2) data regarding the number of evaluators, bed capacity, physicians, and other resources needed to provide timely competency services;
- (3) the steps taken in the previous months to implement this order;
- (4) when and what results are intended to be realized by each of these steps;
- (5) the results realized in the previous month;
- (6) the steps planned to be taken in the following month;
- (7) certification by Defendants that they are fully compliant with all deadlines that became due in the previous month;
- (8) Defendants' estimate for when the wait times will reach seven days or less, and all data relied on in making that estimate; and
- (9) any other information the Monitor informs Defendants is necessary for the Monitor to fully review Defendants' actions and advise the Court."

This order was modified on February 8, 2016. Reporting on the remaining requirements of the February 8 order are below and do not include items previously reported as complete.

#### Analysis of Data: April 1, 2015 through May 30, 2016

The average monthly referrals for each type of service over the one-year period are as follows:

- Average monthly jail-based evaluation orders signed for April 2015-May 2016
  - WSH: 198.6ESH: 41.9
  - Both hospitals: 240.2
- o Average monthly inpatient evaluation orders signed for April 2015- May 2016
  - WSH: 14.1ESH: 5
  - Both hospitals: 19.1
- Average monthly restoration orders signed for April 2015- May 2016
  - WSH: 65ESH: 10.7
  - both hospitals: 75.7

#### <u>Summary Points related to orders and timeliness</u>:

- Jail-based evaluations, orders for both hospitals rose in May. WSH was at 208 which is higher than the 198.6 average. ESH increased to 45 compared with an average of 41.9. Combined, the hospitals totaled 253 orders compared with a 240.2 average.
- In-patient evaluation, orders fell in May, but remain close to average. WSH received 13 compared with a 14.1 average. They fell at ESH to2 compared with an average of 5. The combined count was 15 which is lower than the 19.1 average.
- Restoration orders remained average across both hospitals combined. WSH orders declined in May at 61 versus a 65.2 average. ESH increased to 16 orders compared with a 10.7 average. Combined 77 orders neared the 75.7 average.
- For jail-based evaluation wait times, WSH is averaging 9.6 days from order to completion. ESH is averaging 13.8 days. The combined average is holding steady at 10.4.
- For inpatient evaluation wait times, the WSH average remains consistent at 18.9 days. The ESH average has fallen dramatically from 44 to 12.5 days. The combined average has fallen to 17.8.
- For restoration wait times, WSH lowered in May to 29.1 days from 37.4 in April. *The ESH average has fallen dramatically from 30.4 to 12.2 days.* The combined average has fallen to 26 days.
- Overall timeliness for jail-based evaluations remained steady in May. Combined, 44% were completed within 7 days of the court order, as reflected in a monthly median time of 8 days.
- Overall timeliness for inpatient evaluations improved in May with a 22% completion rate within 7 days (8% on average).
- Overall timeliness for inpatient restorations improved in May with a 28% completion rate within 7 days (22% on average).

#### **Outlier cases**

There are no class members to report waiting more than 100 days. In May, there were 4 patients with an incomplete status and waiting more than 20 days for an evaluation by the end of the reporting period, and 16 patients with an incomplete status and waiting more than 40 days for restoration services. 
# Class Member Status Data Graphs (May data are "First Look" and subject to change)














## **Resources Required to Provide Timely Competency Services**

## **Need Projections and Bed Capacity**

The investment made by the Legislature in the 15-17 biennial budget, and the short and long-term strategies that are being undertaken, will enable Washington to provide competency services within the State/Court established time frames. Washington is making every effort to provide competency services within the seven-day standard as soon as it is financially, physically, staff resource wise possible.

Compliance projections were initially based on the estimates and data included in previous monthly reports, the Long Term Plan dated July 2015, and the May 2016 revised Long Term Plan. An updated projections model is underway by new staff within Decision Support and Evaluation Office and the Office of Forensic Mental Health Services. Once new projections are available, they will be reported in future reports.

There are no additional changes to this resources section regarding funding, FTEs, evaluator positions, and restoration bed counts. When information changes in the future, an update will be included.

# Trueblood Key Accomplishments--May 2016

#### RECRUITMENT

- New announcements have been posted to fill the remaining positions at the Maple Lane Competency Restoration including five Residential Rehabilitation Counselors and three Security Guards. One RRC working graveyard shift started work at Maple Lane on May 22.
- Hiring for the Office of Forensic Services Management positions is complete. Dr. Tom Kinlen, the new Director of Forensic Services, began work on May 4, 2016.
- The data manager position was filled on June 1.
- A LEAN event with all staff involved in the admissions process for WSH occurred on 5/3/16.
   Outcomes of this event included identifying next steps for hiring the Admissions Coordinator position and developing a centralized and more streamlined scheduling and admissions process.
- The Admissions Coordinator position has been posted and closes June 10<sup>th</sup>. Interviews begin in mid- June.
- The Compliance Reporting Specialist job announcement was posted mid-May. Interviews are tentatively planned for the fourth week in June.
- The fourth nurse-focused ESH hiring is scheduled for June 2, 2016 in Spokane.
- A Physician 3 candidate has been identified for a vacant position at ESH. The candidate will be interviewed in early June.
- Alternate qualifications for the Psychiatric Security Attendant (PSA) job class discussions continue and will be explained to the union as contracts enter the negotiation period.

#### RESIDENTIAL TREATMENT FACILITIES

As of May 31, The Yakima Competency Restoration Program had admitted a total of fourteen
patients since opening, with three additional referrals accepted and being admitted the first
week of June. Of those patients six had been opined competent and discharged from the
program; one opined not competent; one determined not likely restorable and one was
transferred to the state hospital due to medical treatment needs.

- As of <u>May 31</u>, the Maple Lane Competency Restoration had admitted a total of twenty patients since opening. Four patients were evaluated by the State Mental Health Evaluator. Of those, three had been opined competent and discharged from the program. One was non-restorable.
- Our most time consuming barrier to filling the beds in these facilities continues to be resolving barriers with patients' court orders. As reported previously, a new court order was developed in Washington and released in early 2016. DSHS continues efforts to educate partners and stakeholders on the new form and the new alternate sites Maple Lane and Yakima. Attorney tours have been hosted at both sites; a fact sheet has been developed and distributed to courts, prosecutors, defense council, the Washington Association of Prosecuting Attorneys (WAPA) and the Washington Association of Sheriffs and Police Chiefs (WASPC); multiple meetings with counties have been held (Clark, King, Chelan, Spokane); our AAGs discuss the new court orders at show cause hearings and bring copies to share; and our AAGs also educate counsel on cases where we are trying to get patients into alternate facilities through a court order revision. DSHS developed a "bed offer memo" to share with attorneys (on cases where the client is a good fit for an alternate site) indicating that a bed at an alternate site is ready with a revised court order.

#### **TECHNOLOGY SOLUTIONS**

- Mobile technology hardware was deployed to 15 evaluators at WSH with twelve more units on order, joining 9 staff already using the hardware at ESH. The use of this hardware is a significant step towards improving timeliness in completing competency evaluations.
- Digital voice recorders will be made available to evaluators to enable them to dictate while
  traveling. This enhancement is expected to save time and increase the number of evaluations
  able to be completed. Analyzing pre and post mobile solutions for evaluators should highlight
  productivity gains. Use of the recorders is now being tested. It will likely take 3-6 months for a
  permanent solution to be rolled out.

# **WAIT TIMES**

- For inpatient evaluations, the *ESH* average has fallen dramatically from 44 to 12.5 days. The combined hospital average has fallen to 17.8 from a 33 day average.
- For restoration, the *ESH average has fallen dramatically from 30.4 to 12.2 days.* The combined hospital average has fallen to 26 days compared with a 32 day average.
