#### **BACKGROUND**

On April 2, 2015, the Court ordered the Department of Social and Health Services (DSHS) to file monthly reports with the *Trueblood* Court Monitor on efforts to comply with Court orders to provide timely competency evaluation and restoration services to Class Members. This monthly report is submitted September 15, 2016 and covers the events of August 2016. This report also provides status updates on additional court order requirements.

#### On April 2, 2015, the Court ordered:

"Defendants shall file a report with the Monitor on the fifth day of every month, which shall include:

- (1) the number of days between when a court ordered provision of competency services and when provision was completed, for each person ordered to receive competency services during the previous month;
- (2) data regarding the number of evaluators, bed capacity, physicians, and other resources needed to provide timely competency services;
- (3) the steps taken in the previous months to implement this order;
- (4) when and what results are intended to be realized by each of these steps;
- (5) the results realized in the previous month;
- (6) the steps planned to be taken in the following month;
- (7) certification by Defendants that they are fully compliant with all deadlines that became due in the previous month;
- (8) Defendants' estimate for when the wait times will reach seven days or less, and all data relied on in making that estimate; and
- (9) any other information the Monitor informs Defendants is necessary for the Monitor to fully review Defendants' actions and advise the Court."

The April 2015 order was modified on February 8, 2016, another order was issued on July 7<sup>th</sup>, and another order was issued on August 15, 2016. Status updates on these orders begin on page 28.

This report provides the class member data for Competency Services displayed in two periods—July 1, 2016 – July 31, 2016 and Aug 1, 2016 - Aug 31, 2016. The July data are considered "mature" and the August data are a "first look" data set. April 2015 is the baseline month for data analysis.

Specific class member evaluation and restoration information is included in the appendices to this report.

#### CLASS MEMBER STATUS SUMMARY INFORMATION

#### Analysis of Data: April 1, 2015 through August 31, 2016

The average monthly referrals for each type of service are as follows:

o Average monthly jail-based evaluation orders signed for April 2015-August 2016

WSH: 202.5ESH: 44.1

Both hospitals: 246.4

Average monthly inpatient evaluation orders signed for April 2015- August 2016

WSH: 15.8ESH: 5.1

Both hospitals: 20.9

o Average monthly restoration orders signed for April 2015- August 2016

WSH: 67.6ESH: 11.2

both hospitals: 78.8

#### Summary Points Related to Orders and Timeliness (see Tables 1-3 below for details)

- Jail-based evaluation orders decreased in August by count for WSH, increased slightly by count at ESH, but still remain higher than the average at both sites. WSH was at 210 which is lower than the 246.4 average. ESH had 47 orders which is higher than the 44.1 average. Combined, the hospitals totaled 257 orders compared with a 246.4 average.
- In-patient evaluation orders at both sites increased from 21 in July to 38 in August which is higher than the 20.9 average. WSH received 30 compared with a 15.8 average (*almost double*). ESH had 8 orders which is higher than the 5.1 average (*near double*).
- There were 100 restoration orders across both hospitals, up from 80 in July (average was 78.8). WSH orders increased to 93 in August versus 69 in July. ESH decreased to 7 orders in August compared with 11 in July.
- Jail-based evaluation wait times remain relatively stable this month. WSH is averaging 13 days from
  order to completion (12.2 last month). ESH is averaging 14.4 days (down from 16 days in July). The
  combined average is 13.2 days. Ten more orders were received this month over the average since April
  2015.
- Inpatient evaluation wait times are improving. The WSH average decreased to 13.8 days from 17.3 days in July. The ESH average also dropped in August to 4.8 days compared with 20.2 in July. The combined average has fallen to 11.6 from 16.6.
- Restoration wait times are improving despite receiving 20 more orders than the average in August. WSH dropped to 13.1 days on average in August from 21.8 in July. The ESH average for August was 4.6 days, down from 7.2 days in July. The combined average has fallen to 12.4 days from 20.4 days.
- Overall timeliness for jail-based evaluations improved to 51% being completed within 14 days.
- Overall timeliness for inpatient evaluations improved to a 38% completion rate within 7 days (up from 8% in July).
- Overall timeliness for inpatient restorations improved to a 28% completion rate within 7 days (up from 19% in July).

#### **Outlier cases**

There are no class members to report waiting more than 100 days. In August, there were 0 patients from ESH and 12 patients from WSH with an incomplete status and waiting more than 20 days for an evaluation by the end of the reporting period. There were 0 patients from ESH and 1 patient from WSH with an incomplete status and waiting more than 40 days for restoration services. FIGURE 1. Evaluation Orders






FIGURE 2. Restoration Orders



FIGURE 3. Evaluations – Median











FIGURE 5. Restorations - Median

#### RESOURCES REQUIRED TO PROVIDE TIMELY COMPETENCY SERVICES

#### **Need Projections and Bed Capacity**

The investment made by the Legislature in the 15-17 biennial budget, and the short and long-term strategies that are being undertaken, will enable Washington to provide competency services in accordance with the established time limits. Washington is making every effort to provide competency services within the seven-day and fourteen-day standards as soon as it is possible.

Compliance projections were initially based on the estimates and data included in previous monthly reports, the Long Term Plan dated July 2015, and the May 2016 revised Long Term Plan. An updated projection model has

been developed and preliminary results were submitted to Dr. Danna Mauch on July 29, 2016. Improvements to this model are underway and include:

- 1. Utilization of more historical data 12 months (vs. 6 months) of daily historical data (August 2015 July 2016);
- 2. Employed statistical models that allow for dynamic interactions among the factors in projections;
- 3. Incorporated growth demand for new orders into the model that were represented by
  - (a) Mental health prevalence estimate among WA's projected arrest population, and
  - (b) An 8% annual increase in new orders
- 4. Accounted for seasonality in the model.

OFMHS plans to submit an additional draft of the model as it is refined and ultimately finalized.

There are no additional changes to this resources section regarding funding, FTEs, or evaluator positions.

#### TRUEBLOOD KEY ACCOMPLISHMENTS - AUGUST 2016

#### RECRUITMENT

- Union contract negotiations must be completed by midnight on October 1st. The Coalition psychiatrists, physicians and pharmacists and WFSE psychologists, forensic evaluators as well as the
  majority of direct care staff except for nurses, have bargaining dates scheduled through mid-September.
  SEIU contract negotiations have concluded. It is important to note that all of the contracts are subject to
  legislative approval.
- A recruitment effort for forensic psychologists and forensic psychologist supervisors is underway for the OFMHS. An aggressive outreach strategy has identified a number of well qualified candidates throughout the month of August – usually the slowest recruiting month in the year. Interviewing of quality candidates has begun.
- DSHS has recruited 874 candidates to fill 178 positions at WSH by November 1. With the exception of
  psychiatrists and physicians, DSHS has more than enough candidates to fill all vacant positions. Related
  updates include:
  - Recruitment efforts for psychologists, LPNs, PSNs, RN 2/3s, MHTs and PSAs at WSH have attracted over 600 new applicants from July 1 through August 31, 2016. The majority of these candidates (over 90%) have come from outside DSHS.
  - Advertising efforts for nurses through the Washington State Nurses Commission have proven successful. Although contact information cannot be tracked because the ad appeared in hard copy, applicants have mentioned that they saw or heard about recruitment efforts through the publication.
  - The recruitment team at headquarters has continued aggressive outreach to potential
    candidates throughout the month of August. Although actual applicant numbers have fallen
    slightly in the last week of August, the third phase of the recruitment strategy takes effect
    September 1 when the summer vacation season ends. Currently there enough applicants in the
    pools to fill most positions.
  - Transitioning military candidates have been, and will continue to be, prime targets of the recruitment team. Advertising purchased in August from the Military Medical News has brought transitioning military candidates into the candidate pools. This campaign will continue through October 2016.
  - Successes aside, employment attrition took its toll at WSH. WSH gained 23 new hires in August, but lost 20 employees.

#### **RESIDENTIAL TREATMENT FACILITIES**

- As of August 31, the census at the Yakima Competency Restoration Program was 16, and they have admitted a total of 45 patients since opening. Fifteen patients have been recommended for early evaluation. Of these 15, 14 have been opined competent and 1 opined not likely restorable. Of the 29 discharged, 20 were opined competent; 4 opined not competent and re-admitted for a second period of restoration services; 1 opined non competent and awaiting 2<sup>nd</sup> order of competency for readmission, 1 opined not likely restorable and care transferred to state hospital; and 3 were transferred to receive restoration services at the state hospital.
- As of August 31st, the census at the Maple Lane Competency Restoration Program was 26, and they have admitted a total of 72 patients since opening. Fifteen patients have been recommended for early evaluation. Of these 15, 12 have been opined competent and 1 opined not competent (patient was reevaluated 9 days later and opined competent), 2 were referred for non-restorability and opined non-restorable. 46 patients have been discharged. Of those discharged, 26 were opined competent, 7 opined not likely restorable; 6 not competent (misdemeanors without additional competency time available), 1 discharged to jail, and returned for a 2<sup>nd</sup> 90 after court, 1 was returned to jail, and 5 were transferred to receive restoration services at the state hospital.
- DSHS initially developed two primary pathways to refer a patient to an alternate site. One of these pathways includes identifying and screening patients from the WSH waitlist, and referring appropriate cases to the alternate sites for review and approval/denial. To date, this pathway has been able to achieve approximately 66% occupancy at the alternate sites. The other pathway includes considering current patients within the competency restoration wards at the two state hospitals. During the month of August, each restoration patient at WSH was reviewed to determine which, if any, might be appropriate for transfer to an RTF. Eight patients were identified and each will be transferred to an RTF before close of business 9/6/16.
- Darla Dawson, OFMHS's Central Admissions Coordinator, begun work on 8/22/16. She is expected to assist in streamlining the admissions process, including referrals to the alternate sites.

#### MOBILE TECHNOLOGY SOLUTIONS FOR EVALUTORS

- Mobile technology hardware (laptops and software) have been deployed to all Forensic Evaluators who expressed interest in using the technology (36 total).
- Two-factor authentication set-up by DSHS Enterprise Technology has been requested for the 36 evaluators. In addition, we are testing a superior remote access method (VPN Virtual Private Network) in place of using Citrix. This has been tested by the State Hospitals Integration Manager and is being tried out at ESH and WSH by one evaluator from each location.
- DSHS has prepared a pilot plan for use of Dragon dictation software by forensic evaluators. Dragon is a "natural language processor" which eliminates the need for transcription. All reports on use of Dragon so far have been positive.

#### **WAIT TIMES**

- For restoration, the ESH average has fallen to 4.6 days in August and they are at a 100% compliance rate with the 7 day standard. The combined hospital average has fallen to 12.4 days in August.
- For inpatient evaluation, the ESH average has fallen to 4.8 days in August and they are at a 100% compliance rate with the 7 day standard. The combined hospital average has fallen to 11.6 days in August.

#### **JULY 7, 2016 CONTEMPT ORDER STATUS UPDATES**

The three status updates required in the July 7th Court Order are below.

- 1. Monetary sanctions fines are imposed on a per class member, per day basis. On the 15<sup>th</sup> of every month, DSHS is required to submit contempt fines data to the court. These data will be submitted to the court on September 15, 2016 and will be included in this report when finalized as Appendix I.
- 2. Diversion plans DSHS is ordered to develop, in consultation with the Court Monitor, plans for the expenditure of the contempt fines. The Diversion Workgroup submitted the court ordered Diversion Plan on August 19, 2016. The first submission to the court was due on August 20.
- 3. Wait time data DSHS shall submit to the Court wait time data in a manner identical to the data submitted on June 17, 2016 in the declaration of Bryan Zolnikov. These data are included in this report in Table 4.

## AUGUST 15, 2016 ORDER MODIFYING PERMANENT INJUCTION AS TO IN JAIL COMPETENCY EVALUATIONS

DSHS must provide in-jail competency evaluations within 14 days of the signing of a court order. Where an in-jail evaluation cannot be completed within 14 days for those individuals where good cause applies (i.e., delay due to clinical reasons, attorney, interpreter, or defense expert), an extension from the ordering court must be secured or must immediately admit the individual to a state hospital to finish conducting the evaluation. In order to comply with the reporting requirements of the Court's order, DSHS identified a need to revise both the current process used for seeking extensions from the criminal court, as well as the data collected during that process. Since the August 15<sup>th</sup> court order, DSHS has identified a series of necessary changes that will enable DSHS to comply with the order, to include the following:

- 1. Develop a list of data elements needed to comply with the court order to include additional delay data;
- 2. Develop a data dictionary to define the data elements needed;
- 3. Develop a process of reporting the information to the courts for the extension requests;
- 4. Identify the cutoff date for seeking an extension;
- 5. Develop a standardized form that can be used for seeking good cause exceptions;
- 6. Develop an operating procedure to guide evaluators through the new good cause process;
- 7. Coordinate with the Attorney General's Office to ensure adequate representation;
- 8. Develop a process for collecting the data to report to the courts for the extensions and to maintain for monthly reporting;
- 9. Develop a model for the delays and the data pertaining to the delays;
- 10. Modify the current IT systems or develop a new database in which to maintain the information once all above steps are completed.

To date, DSHS has completed identifying the data elements, a process for the evaluators to collect the data that will be entered and reported to the courts, a draft of the data dictionary and the process of reporting the information to the courts and identifying a cutoff date for seeking an extension is near completion. Work is ongoing with the Attorney General's Office to finalize the forms and processes for the new good cause procedure. Interim steps for maintaining the data for monthly reporting have been identified and will be implemented using the current IT systems until the current IT system can be modified or a new database can be developed to maintain all of the necessary data.
