# BUILDING 27 PROJECT FORT STEILACOOM COMPETENCY RESTORATION PROGRAM

Expanding Restoration Treatment Options in Washington

## **Project Summary**

Building 27, located on Western State Hospital campus, will be remodeled as a Residential Treatment Facility (RTF) to provide competency restoration treatment services to 30 patients. This project is a collaborative effort between DSHS and the plaintiffs in the *Trueblood et al v. Washington State Department of Social and Health Services (Trueblood)* federal court case. *Trueblood* requires that when a defendant is found not competent to stand trial, they may not wait longer than seven days to be placed into treatment. The Building 27 RTF will add 30 additional beds.

### **Completed Milestones**

- The continuity of operations plan is complete.
- Initial ordering for the facility is complete.
- The social learning program is complete.

### Active Issues/Risks (High-level)

- ❖ DOH has approved our Behavioral Health Certification but requires additional assurance that clinical supervision requirements are met according to WAC-246-341.
- No CMO/WSH FTEs were approved in the compromised budget. The MOU will continue to be reworked with WSH to account for needed services for operation.
- ❖ Filling beds in B27 (and all restoration beds statewide) requires that patients in *any county* be able to be referred and treated in any competency restoration facility. This transition is significant, and the *Statewide Competency Restorations Referral Project* is underway to support this work.
- Modifications to the construction scope of work will continue to evolve as planning progresses. Changes to the scope of work may translate into higher costs than previously expected and impact the overall timeline.
- ❖ As B27 will employ state employees, new positions may translate into large gaps for other agencies and programs.
- ❖ B27 remains in a modified fire watch status.

#### Closed Issues/Risks (High-level)

- ❖ <u>Issue</u>: DEA licensure must occur after HCE licensure. HCE licensure can only be approved once the Pyxis machine is installed on site (after 6/12). The DEA application is prepared but cannot be submitted until HCE licensure is in place and takes 4-6 weeks to process. <u>Closure</u>: DSHS learned from DOH in engaging the DEA that the processing time is 1.5 weeks. This waiting time should not delay opening.
- ❖ Issue: WSH is entering a new Pyxis lease with Care Fusion. The B27 machine is a part of this lease. DSHS signature on the lease was pending completion of the design review process until 5/1/19 when a work around was identified. With a new purchase order underway, it is not yet known when the machine will be delivered to the unit. DSHS is currently assessing timeline impacts to the project. Closure: B27 will borrow a machine from WSH until the new one is ready and arrives on campus.
- ❖ <u>Issue</u>: There is a delay regarding the first installation of windows. The updated installation date is 7/11/19. DSHS is currently assessing impacts to the project. <u>Closure</u>: Window completion was moved up to 6/28 and will not delay the project.

#### **Additional Updates**

- Work is expected to be complete on the radio expansion project by the end of June.
- All IT systems are on track and set for installation. These systems include intercom, staff duress, wireless access, security cameras, card reader system, workstations, phones, cabling, etc.
- ❖ Keys are anticipated July 11<sup>th</sup>. First patient is anticipated the week of July 29<sup>th</sup>.
- ❖ The program is 72% hired. The third training cohort began on 6/3. A fourth cohort was added and will begin on 6/17.
- ❖ The planning process on how we will celebrate turnover of the building is taking shape.

  Stakeholder tours are planned for the middle of July to include Western State Hospital staff, legislators, school district members, etc. A date for the open house and ribbon cutting will soon he set
- ❖ DOH completed their Behavioral Health Agency Certification inspection on 5/29/19.
- Planning to accept the first patient is underway and includes the development of work instructions, FDS updates, admissions staff training, partner communication, patient drop training with transporting jails, etc.
