CRITERIA USED FOR CASES TO BE INCLUDED IN DCS KALISPEL TRIBAL CASELOAD

In the Spokane Office, DCS has designated a specialized Kalispel caseload for working cases affiliated with the Kalispel Tribe of Indians. **Amanda James** is the primary contact for this caseload. This caseload is comprised of cases that meet one or more of the following criteria:

- An NCP is a Kalispel Tribal member (must self-identify as tribal member)
- An enforcement case where an NCP is working for the Kalispel Tribe, Tribal business or enterprise, or an Indian owned business located on the Reservation
- All paternity establishment cases: Where at least one party is American Indian and all of the parties are subject to or consent to, Tribal Court jurisdiction (parties must self-identify as tribal members)
- All child support establishment/modification cases where the NCP resides on the reservation
- All associated NCP cases related to one of the above criteria

NCP = Non-Custodial Parent, the person paying child support

CP = Custodial Parent, the person receiving child support
