8	HealthPath Washington Managed Care	Funding is requested for staffing costs for the Centers for Medicare and Medicaid (CMS) Financial Alignment Integration Demonstrations. CMS has approved Washington to implement two shared savings models of care. The first, Health Homes, provides intensive care coordination and increased communication among the client's providers. The second, HealthPath Washington (Managed Care), will contract with managed care organizations to deliver Medicare and Medicaid services, including long term services and supports and behavioral health services, in King and Snohomish counties to achieve better health outcomes at less cost than traditional fee for service delivery.	\$190,000	\$1,312,000
