



#### Afghan Arrivals in Washington 2021 – 2022 Total Arrivals: 4,432 people







On April 21, 2022, President Biden announced Uniting for Ukraine, a new streamlined process to provide Ukrainian citizens and their immediate family members who have fled Russia's unprovoked war of aggression opportunities to come to the United States and stay temporarily, with a period of parole up to two years.



#### Purpose:

- Established by the Governor's Office in August 2020 and continued by the Washington State Legislature.
- Community-based and driven.
- Distribute cash assistance to people affected by the pandemic who are ineligible for federal economic stimulus funding or unemployment insurance due to their immigration status.

#### Funding 2020-2021:

- \$127.6 million federal CARES Act Funding allocated in 2020-2021.
  - \$121,850,000 allocated to individual grants.

#### Funding 2022-2023:

- \$340 million of coronavirus federal funding. \$306 million to be released in grants.
- Open application Sept. 19 Nov. 14, 2022. Application will be live on <u>www.immigrantreliefwa.org</u>



### Uniting for Ukraine – Updated Health Requirements

Requirement	Pre-arrival attestation	Post-arrival attestation
TB Screening	None	IGRA test and follow-up within 90 days for everyone ages 2 and older
COVID-19 vaccine	If authorized COVID-19 vaccine available, receive at least 1 dose.	Complete COVID-19 vaccine series within 90 days of arrival for everyone ages 6 months and older
Measles vaccine	Receive at least 1 dose of measles vaccine	None
Polio vaccine	If polio vaccine available for age, receive at least 1 dose	Receive polio vaccine, if needed for everyone ages 6 weeks and older

### Air Quality Index

Air Quality Index	What Should I Do?			
<b>Good</b> 0-50	It's a great day to be active outside and a good time to make a plan if worse air quality is in the forecast.			
Moderate 51-100	Some people are especially sensitive to lower levels of particle pollution and should reduce exposure. For example, limit time outside and avoid strenuous outdoor activity. All sensitive groups should watch for symptoms.			
Unhealthy for Sensitive Groups 101-150	Sensitive groups should take steps to reduce exposure. Limit time outside, avoid strenuous outdoor activity, and follow tips for cleaner indoor air. Everyone should watch for symptoms as a sign to reduce exposure.			
Unhealthy 151–200	Everyone should reduce exposure. Limit time outside, avoid strenuous outdoor activity, and follow tips for cleaner indoor air.			
Very Unhealthy 201–300	Everyone should reduce exposure. Stay inside and filter indoor air to keep it cleaner. Go elsewhere for cleaner air, if needed.			
Hazardous >300	Everyone should reduce exposure. Stay inside and filter indoor air to keep it cleaner. Go elsewhere for cleaner air, if needed.

### COVID-19 Booster Doses

#### Updated COVID-19 Booster Doses

New boosters are now available to provide increased protection against Omicron variants.

#### When to get the updated booster

At least 2 months after your last COVID-19 dose – either a booster dose or your primary series.

#### Who should get the updated booster

Individuals age 12 and up are eligible for the updated Pfizer booster, and adults age 18 and up are eligible for the updated Moderna booster.

# **ORIA BFET**

Services under the ORIA BFET program include:

- Job Search
- English as a Second Language (ESL) training
- Vocational education and training
- Case management
- Job retention services
- Support services

# **ORIA BFET**

An individual is eligible to receive ORIA BFET services if they are:

- 16 years or older
- Receiving Basic Food Assistance from DSHS
- A refugee or immigrant
- Not receiving TANF, Refugee Cash Assistance (RCA), or other cash assistance under Title IV

# **ORIA BFET**

ORIA BFET services are available in the following locations:

- King County (Seattle, Kent, SeaTac, Tukwila)
- Pierce County (Tacoma)
- Snohomish County (Everett)
- Clark County (Vancouver)
- Spokane County (Spokane)

- FAP is for authorized immigrants who meet all the Basic Food requirements, except citizenship or alien status.

**Eligibility:** Immigration Status (Refugee, Asylee, SIV, Afghan Parolee, Ukrainian Parolee, Amerasian, Cuban-Haitian, Victim of Human Trafficking), less than 5 years in US, not yet naturalized, have a professional, education and/or vocational background they are hoping to reenter.
