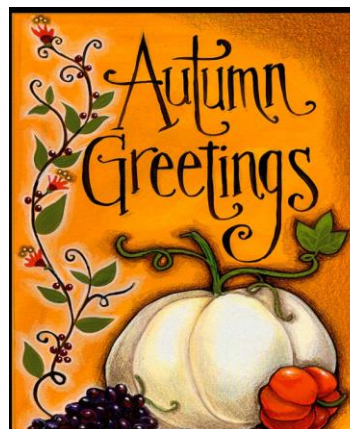

## Disqualifying List of Crimes and Negative Actions

Certain criminal convictions, pending charges, and negative actions automatically disqualify a person from having unsupervised access to vulnerable adults, juveniles, and children, or access to federal tax information. These disqualifying lists can be found [here](#). If you have questions about which list applies to your background checks, contact the appropriate DSHS oversight program. For DSHS employee background checks, contact the Human Resources Division (HRD).

### NEW DSHS Secretary's List of Crimes and Negative Actions

The following offenses were added to the list in August:

1. Permitting Commercial Sexual Abuse of a Minor (RCW 9.68A.103) – permanently disqualifying,
2. Promoting Travel for Commercial Sexual Abuse of a Minor (RCW 9.68A.102) – permanently disqualifying,
3. Viewing Depictions of a Minor Engaged in Sexually Explicit Conduct (RCW 9.68A.075) – permanently disqualifying,
4. Hate Crime (RCW 9A.36.080) – permanently disqualifying,
5. Trafficking (RCW 9A.40.100) – permanently disqualifying,
6. False statements, Fraud (RCW 74.09.230) – disqualifying for 5 years, and
8. Theft of a firearm (RCW 9A.56.300) – disqualifying for 5 years.

## SET APPLICANTS UP FOR SUCCESS



Give applicant instructions on where to go to complete the background check authorization form and where to send the confirmation code and their Date of Birth once the form is completed.

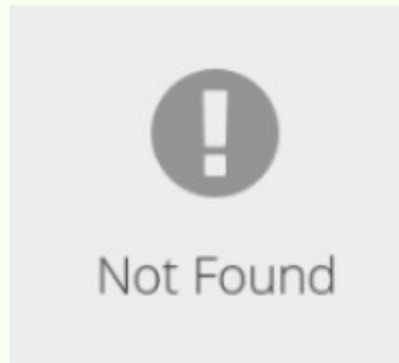

### KEY POINTS

- Confirmation codes should not be sent to BCCU.
- Completing the online Background Check Authorization Form does not submit the background check to BCCU for processing.
- Save the confirmation code as BCCU cannot retrieve the code.
- Confirmation codes expire after 90 days.



### **APPLICANT FORM NOT FOUND**

Entity account users, when you are entering the confirmation code and date of birth in BCS and see the "No Applicant Form found" error message, this indicates that either the confirmation code is incorrect, expired, or the date of birth on the submitted background authorization form does not match what is being entered in BCS. We recommend if the applicant did not forward you the email that they received, asking them to forward it to you, so you can copy and paste it directly from the email, and double check that there are no spaces before or after the confirmation code. You will also want to double check that the confirmation email the applicant received is not older than 90 days and verify that the date of birth is correct.

If you are still unable to get it to pull up in the system once you've tried all of the above, the applicant will have to fill out a new background authorization form, and give you the new confirmation code, as confirmation codes are stored on a secure server and BCCU does not have access to them.

## **Paper Background Check Authorization Forms**

BCCU continues to get paper forms through fax, mail, and email. We no longer accept these forms or retain copies.

The online Background Check System (BCS) is available for entities to receive, process, and view background check results. Once the applicant has completed the online Background Check Authorization form, a confirmation code is produced so that you (the entity) can pull the form from the secure online database.

Once you receive the confirmation code and date of birth from the applicant, you will need to login to your Background Check System (BCS) account to submit their background check request to our office for processing.



In March of 2020, Governor Inslee introduced an emergency proclamation that temporarily suspended the law that requires long-term care workers to complete fingerprint-based background checks. As a result, BCCU temporarily stopped closing (expiring) background check inquiries in the Background Check System (BCS). On October 27, 2022, the emergency proclamation was lifted and therefore BCCU is planning to reintroduce closing (expiring) background check inquiries beginning **January 1st, 2024**

### **What this means:**

- 1. Background checks for applicants with pending fingerprints older than 6 months (from the date the interim result was issued) who have not been printed will be expired.**
- 2. Background checks for applicants where additional information was requested but not received by BCCU and are passed 6 months (from the date the additional information was requested) will be expired.**
- 3. Background checks for applicants that have not resubmitted fingerprints after the fingerprints were rejected by WSP or the FBI and 372 days have passed (from the date the first fingerprints were transmitted) will be expired.**

### **Action Item:**

Review any background checks in the below statuses in BCS and if needed work with the applicant to schedule fingerprinting or provide additional information requested by BCCU. If the background check expires before action is taken, the applicant will need to submit a new background check application. If you are no longer pursuing the applicant, you can archive the inquiry and no additional action is needed.

# IdentoGO/Idemia Announces New Website URL

IdentoGO/Idemia is in the process of retiring the [ibt.fingerprint.com](http://ibt.fingerprint.com) and [11enrollment.com](http://11enrollment.com) domains. The old URLs will be directed to the new URL until December 31st, 2023. BCCU is working to update the URLs contained on our website and applicant resources.

**Action Item:** Please check any fingerprint resource material you may have created for applicants and update the URL if needed.

## Fingerprint Turnaround Times

The WSP and FBI turnaround times can vary due to the volume of fingerprints being processed or other factors.

The turnaround time on prints also depends on whether the fingerprint cards are the first set of prints submitted for the associated inquiry ID/OCA number or if they are resubmitted prints. The first set of prints is submitted electronically, allowing for a faster turnaround time. However, the resubmitted prints require a hard card to be printed and mailed, causing slower turnaround times.

If an inquiry has been "Pending Fingerprint Results" for over 14 business days, please contact BCCU.

### Exciting update in the fingerprinting world!

Effective October 26, 2023 out of state fingerprinting is an option for our applicants in select states with IdentoGO/IDEMIA.

Out-Of-State Livescan Processing:

1. Pre-enroll for Livescan Processing at <https://wa.ibtfingerprint.com>, selecting the Out-Of-State Digital Fingerprinting Services (Live Scan) (image above).
2. Select the appropriate Agency and enter any required information associated with your selection.
3. Enter your out of state zip code.
4. Identify the nearest IdentoGO Center and continue pre-enrollment process.

The following is a list of states that will be offering out of state printing: AZ, CA, CO, DE, FL, GA, IL, KY, LA, MA, MD, MI, MN, MO, ND, NJ, NY, OK, PA, SC, TN, TX, VA, WI, WV. Please note, there is no radius requirements for locations in other states.

\*If no Enrollment Center is available within a 100-mile radius, applicants will see a prompt notifying them that they will need to provide a different zip code. If there is not an Enrollment Center in the applicant's area, the applicant will not be able to register for our card scan submission process. Applicants will have the ability to enter a different zip code for a search of locations.

# Idemia Partner Program

## CHECK OUT OUR STATS FOR SEPTEMBER



### BACKGROUND CHECKS:

#### **25,197 Incoming Background Checks**

- ▶ 11,380 – Name and Date of Birth (NDOB)
- ▶ 13,817 – Fingerprint (FP)



**2,017** less background checks submitted than the previous month



**1,271** more background checks Fiscal Year to Date (FYTD)  
(75,724 FYTD 9/2022 compared to 76,995 FYTD 9/2023)

On average, more than **80%** of background checks go through the Background Check System Quick Return process with little or no BCCU staff intervention giving requesting entities background check results same day.
