Nge ew chok, kich sisapw apwarano rekoton SUD kena ren nefinen aramas, chon atai annuk, ofesin atowowu, me pwan foforan legislative kena ngonuk, nge ika chok pwe ka amutata non maak, ika non ponu ngeni ew orderin kapung.
