<p><input type="checkbox"/> <b>Purpose</b> DSHS provides cash grants to low-income residents who qualify for public assistance programs. These benefits help pay for basic living expenses (RCW 74.04.770).  TANF cash grants must be used only for the benefit of children in your care. We can require proof you are using your TANF grant for the children's needs (RCW 74.12.260).</p> <hr/> <p><input type="checkbox"/> <b>Appropriate Use</b> You may use your cash grant for living expenses such as:</p> <ul style="list-style-type: none"> <li>• Shelter</li> <li>• Fuel</li> <li>• Food</li> <li>• Transportation</li> <li>• Clothing</li> <li>• Home maintenance</li> <li>• Personal hygiene</li> <li>• Employment expenses</li> </ul> <hr/> <p><input type="checkbox"/> <b>Illegal Use</b> Under RCW 74.08.580, it's not legal to use Electronic Benefit Transfer (EBT) cards or cash from EBT cards to:</p> <ul style="list-style-type: none"> <li>• Gamble. Gambling includes lottery tickets, pull tabs, punch boards, bingo, horse racing, casino games, and any game of chance found in RCW 9.46, 67.16, and 67.70.</li> <li>• Buy services in tattoo, body piercing, or body art shops.</li> <li>• Buy cigarettes or tobacco.</li> <li>• Buy alcoholic items.</li> <li>• Buy goods or services in: <ul style="list-style-type: none"> <li>○ Taverns.</li> <li>○ Beer or wine shops unless authorized as a SNAP or WIC retailer.</li> <li>○ Nightclubs.</li> <li>○ Bail bond agencies.</li> <li>○ Gambling establishments.</li> <li>○ Adult entertainment venues with erotic performances.</li> <li>○ Any place where someone under the age of 18 isn't allowed <ul style="list-style-type: none"> <li>▪ For example, marijuana retailers where marijuana and/or marijuana-based products are sold.</li> </ul> </li> </ul> </li> </ul>	<p><input type="checkbox"/> <b>Purpose</b> DSHS food assistance programs include:</p> <ul style="list-style-type: none"> <li>• Basic Food.</li> <li>• Food Assistance Program for legal immigrants (FAP).</li> <li>• Washington Combined Application Project (WASHCAP).</li> <li>• Transitional Food Assistance (TFA).</li> </ul> <p>These programs provide assistance for low-income people to buy food with electronic benefits transfer (EBT) cards.</p> <hr/> <p><input type="checkbox"/> <b>Appropriate Use</b> You, and your household, may use your food benefits to buy food from a retailer authorized by the USDA, Food and Nutrition Service (FNS).  You may use your benefits to buy:</p> <ul style="list-style-type: none"> <li>• Breads and cereals.</li> <li>• Fruits and vegetables.</li> <li>• Cheese, milk, and dairy products.</li> <li>• Meats, fish, poultry, and eggs.</li> <li>• Most food other than prepared hot foods.</li> <li>• Seeds and plants that produce food.</li> </ul> <hr/> <p><input type="checkbox"/> <b>Illegal Use</b> It is illegal to:</p> <ul style="list-style-type: none"> <li>• Use food benefits for anything other than to buy food for eligible household members.</li> <li>• Sell, or attempt to sell, your EBT card.</li> <li>• Exchange your benefits, or the food purchased with your EBT card, for anything of value (trafficking). Examples of illegal trafficking include exchanging food benefits for cash, drugs, or weapons.</li> <li>• Give your benefits to anyone who isn't in your household.</li> <li>• Use food benefits to buy non-food items. Examples include cigarettes, tobacco, beer, wine, liquor, household supplies, soap, paper products, vitamins, medicine, or pet food.</li> <li>• Use your food benefits to pay on credit accounts.</li> </ul>

<p><input type="checkbox"/> <b>Penalty for Illegal Use</b></p> <p>If you use your EBT card or cash from your EBT card illegally or inappropriately, we may:</p> <ul style="list-style-type: none"> <li>• Assign a protective payee to manage your cash grant.</li> <li>• Require proof you use your grant for the children in your care.</li> <li>• Terminate your cash benefits.</li> <li>• Pursue legal action, including criminal prosecution.</li> </ul> <p><input type="checkbox"/> <b>Automated Teller machine (ATM) fees for EBT Withdrawals</b></p> <p>When you use your EBT card to make cash withdrawals at an ATM:</p> <ul style="list-style-type: none"> <li>• The ATM owner or bank operating the machine may charge a surcharge fee.</li> <li>• The department does not pay or reimburse for ATM surcharge fees.</li> <li>• You may be able to get cash back from some stores without a fee.</li> </ul>	<p><input type="checkbox"/> <b>Penalty for Illegal Use</b></p> <p>If you intentionally misuse your food benefits, you may be:</p> <ul style="list-style-type: none"> <li>• Required to repay any trafficked benefits.</li> <li>• Disqualified and lose your benefits: <ul style="list-style-type: none"> <li>○ For at least one year.</li> <li>○ Up to a lifetime.</li> <li>○ Be disqualified even if you move to another state.</li> </ul> </li> <li>• Subject to fines.</li> <li>• Subject to legal action, including criminal prosecution.</li> </ul> <p>DSHS will cooperate with state, local, and federal authorities to prosecute trafficking of food benefits.</p>

I understand my eligibility for DSHS benefits isn't affected if I don't sign this form. I understand DSHS will use this information, and my history of requests for replacement cards, to investigate misuse of cash grants or food benefits.</p>
