Nupwen en ka angei TANF ren ekkewe semirit non eom tumun, iwe en kopwe kan anisi ewe Department of Social and Health Service (Pwutain Aninisin Non Neni me Safei, DSHS), Division of Child Support (Pekin Aninisin Semirit, DCS), ioni aninisin semirit nge ika chok pwe ese kan tumun reomw ika ekkewe semirit. Community Services Division (Kinikinin Aninisin Non Neni, CSD) a finata eom naf ngeni ren TANF me pwan atotokono ngeni DCS ren an epwe awora unusen apechakunen aninisin aninis kena nupwen en ika ekkewe semirit ra angei TANF. Ekkei aninis epwene pachenong DCS apechakuna pwan ew an sam me in kewe met repwe fori ren ar repwe awora insurens ren safei me pwan fesinanong ar momon safei kena rese insure ren ekkewe semirit.

Meta upwene fori ren ai upwe anisi DCS ioni aninisinsemirit?

- Iwe chökkewe mi mochen onómuur lón án.
- Mi riri ngeni fel ngeni ekkewe mi máló.
- Mi papataiselo lon ewe ier ra kapachelong lein chokkewe.

Mi feffeiä ngeni imwenfelin jiowa we imwan we, me ra äiti ngeni pwe?

- Pokiten aninisin semirit a tongeni anisuk angei eochunon pekin noum moni.
- Pokiten a kan ngeni ekkewe semirit ew wuruwon safean family seni sineiin io semer me iner a kan.
- Pokiten a ngeni ewe semirit ew pungun annuk ngeni fangenen kena, social security, aninisin veterans kena me pwan ekkoch governmentaninisir kena.

Met epwene fis ika ngang use fororieoch ngeni DCS?

Ika pwe en ka angei aninis kena ren pusin en me pwan kose kan anisi DCS ioni aninisinsemirit, noum pekin ren ewe amonien moni epwene koturutiw seni 25%. DCS epwene fororino ngeni ionin aninisin semirit nge esapw fiti eom aninis.

Saangoon kapasen pesepes ngeni chon korint ruu DCS?

En kosapw pwan aninis ren ionin aninisin an noumuwe semiritaninis ika pwen noumuwe chon angangen CSD a finata pwe a wor eom eochun popun eom kosapw aninis. Good Cause (Noum We át Seniei) angang esap:

- En ka nuwokus pwe en ika ekkewe semirit non eom tumun repwe afeiangaweno non inisir ika non memefier.
- A silei ach kewe föfför, ekiek, me kapas me mwen.
- En ka kan poputani fororun mowmou kena, ika en ka nom non counseling (ren tameno ngeni wunungat maram) fiti ew ofesin isenanong semirit usun mowmou.

Meta upwene kan ngeni nei we chon angangen CSD ren an epwe pwarano pwe ngang mi wor ei Eochun Popun ai usapw aninis?

- Eom saini echo taropwe a aporaus eom nuwokus kena me pwan nonineng kena (mi pachenong ei taropwe), ika
- Ekkena rekoto mi pachenong safei, polis, taropwen poraus seni family ika chiechieom usun tumun eom kleim, ika mi kawor.
- Kopwene angei 20 ran ren eom kopwe awora ei afatenon ngen en ka kan tongeni eis ren napanon fansoun ika pwe ka mochen.

Met ngang mi chuen tongeni angei aninisinsemirit ioni me pwan angangeoch ngeni DCS?

Ewer, pokiten mei wor ruwow sakkun awukukun kena ina en ka tongeni fini, Level A ika Level B.

- Level A: En kosapw pwan eis pwe kopwe angangeoch ngeni DCS. Aninisin semirit esapw kan ioni.
- Level B: En kosapw pwan eis pwe kopwe angangeoch ngeni DCS nge aninisinsemirit epwene ioni me pwan eom address epwene chuen chok tumun.

Etiwaöchüür me ämmeef ngeniir pwe ka DCS wesewesen pwapwa le küner?

- Kori CSD me pwan noumuwe DCS aninisin semirit officer non mutirin fansoun. Me ra puchoruu ne ungeni nifai ra apasa.
- Mi sinei Good Cause (Noum We át Seniei) nifai a fen tipeew ngeni emon.
- Iwe mwirin i Good Cause (Noum We át Seniei) ngenikich pwe i epwe B, tongeni siwinikich ngeni A an.
- Inisin pwe i emon mwan mi napanap a kefinita seni kot me emon soufos.

Meta epwe fis ika ngang use tipeew ngeni an CSD we finin ren Eochun Popun?

Ren napanapen ach minen kunou mi Administrative Hearing (Sipwe eis Met sokkun) minen kunou ei. Nge Good Cause (Noum We át Seniei) än semirit meefi Administrative Hearing (Sipwe eis Met sokkun) me tongei semer me iner. Nengeni ewe “Administrative Hearing Process (Foforun Arongorongen Ofes)” won ewe nasenon peich ren napanon porausen arongorongen ofes.

Ika pwe mi wor eom kena kapaseis usun aninis ren ionin aninisin semirit kena, iwe eis me mwan eom kopwe saini ei taropwe. Ekkewe noun aramas ina ewe tong ennet ina minne.

- Ese wor an aramas tong ennet rese tongeni nenieni DCS neni minne ka fen amonnata. Ifa usun sia silei pwe än DCS we manaman mi fel a älisi moses le apwönüetä wisan kewe a ereni noun 25% kaeo.
- Nge are oupwe kuna ekkewe mwichen. Kose mochen aporaus eomuwe popun atetenawow eom nuwokus me pwan nonineng kena won ewe peich murin.

Meinisin ususun family kena ra kan kono. Kose mochen cheki meinisin pwor kena me fan ina ra kan aporaus ekkewe popun esapw kan tumun ren ar repwene foforuno ne angei aninisin semirit.

- Ekkewe semirit ra kan fich ngeni foforun moutir seni annuk kena.
- Ewe semirit a kan uputiw pwe ew pungun ren incest ika rape.
- Ngang uwa angei ew amwochunon order ika repotin polis kena ra filed ren ewe sam me in esapw ii epwe iseni.
- Ewe sam me in esapw ii epwe iseni a kan afeiengawa ika anuwokusun an epwe afeiengawei ika ewe semirit.
- Ewe sam me in esapw ii epwe iseni a wor wuruwon ren napenapen afeiengaw.
- Ewe sam me in esapw ii epwe iseni epwene satuni an epwe angei iseisen ekkewe semirit ika pwe aninisin semirit ra kan fofor ngeni, me pwan esapw pwan awora ew nenien mi tumun ren ekkewe semirit.
- Ngang uwa nonineng pwe ewe eochunon nonom ren ekkewe semirit epwene afitikokono.
- Ika pwe aninisinsemirit ra kan fofor ngeni, ewe sam me in ii esapw iseni epwene kan fakkun netipengaw ngeni me pwan fori popun anuwokusun memef ren ekkewe semirit.
- Ewe sam me in esapw ii epwe iseni a kan wor an semwenin nonmokuran ika osupwangen eaeangawen safeingaw ina a kan fen fori afeiengaw ngeniei ika ekkewe semirit.
- Pwan ekkoch, kose mochen aporaus usun eom nuwokus me pwan nonineng kena me fan:
