Waxaad codsan kartaa dhageysiga maamulka la xiriira haddii aadan oggolayn ogeysiiskan. Codsigaaga waa in uu noqdaa mid **goraal** ah kuna dar kuwan soo socda:

- Magacaaga, ciwaankaaga, lambarka teleefoonkaaga, iyo lambarka iibiyaha / daryeel bixiyaha (ku qor bog kasta).
  - Sheeg sababta(sababaha) aad u maleynayso in ogeysiiskan uu yahay mid aan sax ahayn kuna dar wax kasta oo dukumeenti ah oo aad ku xoojin karto.

Haddii lacag-bixintaada dheeraadka ah la yareeyo ama la kordhiyo iyadoo ay sababtuna tahay natijada Dhageysiga Maamulka la xiriira, xaq uma lihid xuquuqaha dhageysiga ee loo marayo Xafiiska Dib-u-celinta Maaliyadaha. Tixraac Amarkaaga Kama-dambeysta ah ee Xuquuqaha Rafcaanka.
