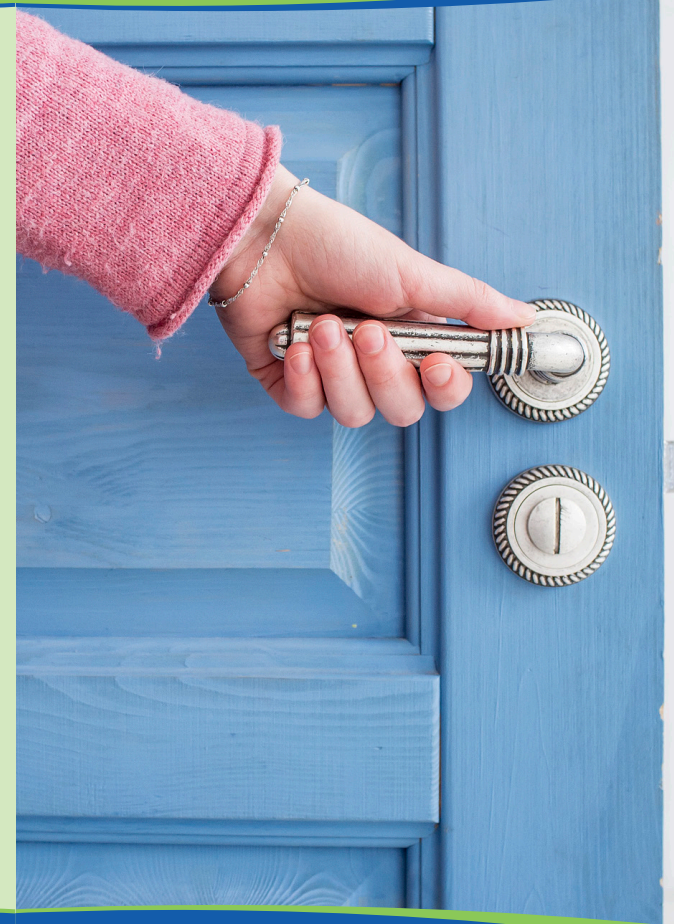

Tenancy Support Services

AL TSA offers eligible in-home clients a number of services to support their goals of living independently. Among service options for eligible individuals are:

- Long-Term Services and Supports Case Manager.
- Personal Care services to assist with Activities of Daily Living (ADLs) and Instrumental ADLs, such as housekeeping.
- Individualized support to search for and maintain independent housing.
- Community Transition and Sustainability Services, such as:
 - Financial assistance for move-in
 - Furniture and household items
 - Assistance related to pest eradication
 - Assistance related to hoarding behaviors
- Intensive Tenancy Support through Supportive Housing services



What is the Aging & Long-Term Support Administration (AL TSA)?

The administration within DSHS that is responsible for promoting, planning, developing and providing long-term care services responsive to the needs of persons with disabilities and older adults.

Most people want to live as independently as possible for as long as possible. AL TSA offers in-home options to individuals requiring long-term care services that honor client choice and housing preference.

AL TSA relies on our valuable partnerships with landlords across Washington to grow and expand independent housing options for AL TSA clients. What is the AL TSA Subsidy?

The AL TSA subsidy is intended to assist AL TSA clients transitioning into independent housing.

The state-funded subsidy provides rental assistance for living in market rate housing while searching for a permanent federal subsidy.

The subsidy holder is responsible for paying approximately 30% of their income towards the cost of the rent directly to the landlord, and the subsidy covers the remainder.

AL TSA contracts with the Spokane Housing Authority to administer the subsidy statewide.
