### Introduction

There have been longstanding national trends—predating the passage of the Affordable Care Act and implementation of Medicaid Expansion—toward an increasing number of employers faced with rising employee health care costs choosing to (a) drop health care benefits for their employees or (b) pass on to their employees a greater share of coverage costs. As a consequence, there have been trends towards more employees and their dependents applying for health care supported with public funds. In response to these trends, the 2006 State Legislature enacted Engrossed Substitute House Bill (ESHB) 3079. This legislation directed the Department of Social and Health Services (DSHS) and the Health Care Authority (HCA), in coordination with the Employment Security Department (ESD), to report annually on the employment of Medical Assistance clients.

This report provides both aggregate and employer-specific data related to clients covered by the Washington State Health Care Authority's Washington Apple Health (Medicaid) program, and nonclient individuals with dependents who have Medicaid coverage, as specified in the legislation (enacted as Chapter 264, Laws of 2006 and codified in RCW 74.09.053 and RCW 70.47.170). Governor Gregoire signed ESHB 3079, but vetoed the emergency clause included in the bill. The Governor's veto message urged caution when interpreting data provided in this report:

The employer information to be provided by the Health Care Authority (HCA) and the Department of Social and Health Services (DSHS) is not a requirement for enrollment or eligibility. Consequently, data contained in the reports will have been provided on a voluntary basis, and will be unverified. The two reports—an employer specific report and an aggregated report—will originate from separate sources. Therefore, they will not be comparable. The reports will also be based on a point-in-time data collection and will therefore not reflect changes in employment status. These data limitations must be considered when interpreting the reports.


ESHB 3079 directs the provision of two separate sets of information related to Medicaid clients and non-client individuals with dependents who are Medicaid clients:

- Aggregate data for calendar year (CY) 2019 by industry, firm size, and public/private ownership type. These data are based on ESD quarterly wage data.
- By-firm data for January and June 2020 for employers associated with 50 or more persons with Medicaid coverage. These data are derived from the DSHS Automated Client Eligibility System (ACES). Due to the required reporting deadline and data availability limitations, April 2020 data are reported in place of June 2020.



# **Key Findings**

- 1. In the average quarter in CY 2019, there were 1,803,147 persons with Washington Apple Health (Medicaid) coverage, excluding clients who received only family planning coverage.
- In the average quarter in CY 2019, there were 352,382 persons with Washington Apple Health (Medicaid) coverage and ESD-reported earnings in the quarter (see Table 2A "All Firms"). This represents about 20 percent of all persons with Washington Apple Health (Medicaid) coverage in the average quarter in CY 2019.
- 3. The 352,382 employed Washington Apple Health (Medicaid) clients had 201,810 dependents with Washington Apple Health (Medicaid) coverage, for an average quarterly total of 554,192 covered lives (see Table 2B "All Firms"). This is 31 percent of all persons with Washington Apple Health (Medicaid) coverage in the average quarter in CY 2019.
- 4. We use the term "employed non-client individuals with dependents with Washington Apple Health (Medicaid) coverage" to refer to employed persons who do not have Washington Apple Health (Medicaid) coverage, but who have dependents with Washington Apple Health (Medicaid) coverage. In the average quarter in CY 2019, there were 148,348 employed non-client individuals with dependents with Washington Apple Health (Medicaid) coverage (see Table 3A "All Firms"). There were 261,512 dependents with



Washington Apple Health (Medicaid) coverage associated with these employed non-clients (see Table 3B "All Firms"). This represents 15 percent of all persons with Washington Apple Health (Medicaid) coverage in the average quarter in CY 2019.

- 5. Combining employed Washington Apple Health (Medicaid) clients and non-clients, there were 500,729 employed Washington Apple Health (Medicaid) clients or non-client individuals with dependents with Washington Apple Health (Medicaid) coverage in the average calendar quarter in CY 2019 (see Table 1A "All Firms").
- 6. In the average quarter in CY 2019, there were 815,704 Washington Apple Health (Medicaid) covered lives associated with the 500,729 employed Washington Apple Health (Medicaid) clients and non-client individuals with dependents with Washington Apple Health (Medicaid) coverage (Table 1B "All Firms"). This represents 45 percent of all persons with Washington Apple Health (Medicaid) coverage in the average quarter in CY 2019.
- The 500,729 employed Washington Apple Health (Medicaid) clients and non-client individuals with dependents with Washington Apple Health (Medicaid) coverage in CY 2019 represented a similar number relative to the 509,300 employed clients and non-clients observed in CY 2018.
- 8. In CY 2019, about 62 percent of employed Washington Apple Health (Medicaid) clients and non-client individuals with dependents with Washington Apple Health (Medicaid) coverage worked for firms with more than 50 employees (see Table 1A "By Firm Size").
- 9. Employed non-client individuals with dependents with Washington Apple Health (Medicaid) coverage worked more hours than employed Washington Apple Health (Medicaid) medical clients. More than half (53 percent) of non-client individuals with dependents with Washington Apple Health (Medicaid) coverage worked full-time (more than 455 hours) in the quarter (Table 3A "All Firms"), compared to only 20 percent of employed Washington Apple Health (Medicaid) clients (Table 2A "All Firms").
- 10. There were about 9.4 million months of HCA medical coverage in CY 2019 associated with employed Washington Apple Health (Medicaid) clients and non-client individuals with dependents with Washington Apple Health (Medicaid) coverage. About 69 percent of the months were associated with employed Washington Apple Health (Medicaid) clients (6.4 million coverage months), and about 31 percent were associated with employed non-client individuals with dependents with Washington Apple Health (Medicaid) coverage (2.9 million coverage months).
- 11. Estimated HCA medical and DSHS mental health expenditures for the months of coverage associated with employed Washington Apple Health (Medicaid) clients and non-client individuals with dependents with Washington Apple Health (Medicaid) coverage were \$1.601 billion in CY 2019 (all funds). Of this total, approximately \$553 million were associated with employed Washington Apple Health (Medicaid) clients, and \$1.048 billion were associated with employed non-client individuals with dependents with Washington Apple Health (Medicaid) clients, and \$1.048 billion were associated with employed non-client individuals with dependents with Washington Apple Health (Medicaid) coverage.



- 12. Associated annual Washington Apple Health (Medicaid) coverage costs were greatest for persons employed in the following industries: Accommodation and Food Services (\$266 million); Health and Social Assistance (\$258 million); and Retail Trade (\$258 million).
- Almost all (92.7 percent) of the annual Washington Apple Health (Medicaid) coverage costs were associated with private employers (\$1.484 billion), as opposed to public employers (\$117 million).
- 14. Detailed information for the largest employers of Washington Apple Health (Medicaid) clients and non-client individuals with dependents with Washington Apple Health (Medicaid) coverage can be found in the supplemental tables at the end of this report.

### Employment Trends for Washington Apple Health (Medicaid) Clients and Non-Clients with Covered Dependents

The table below provides an overview of the trend in the proportion of HCA medical clients associated with employment from 2005 to 2019, as identified using ESD quarterly earnings data. Some of the year-to-year variation in the table below is the result of slight changes in data processing methods over the reporting period. Since the Basic Health Plan (BHP) has been eliminated, BHP enrollees are excluded and the data only reflects HCA Medicaid trend information.

### Data Sources and Limitations

Aggregate data by industry, firm size, and public/private ownership type are based on ESD quarterly earnings data and monthly medical eligibility data for CY 2019. ESD earnings data do not include self-employment, federal government employment, or unreported earnings.

By-firm data are based on ACES employer name data linked to medical eligibility data for January and April 2020. ACES employer name information does not permit the identification of separately owned franchises operating under the same business name. The employer name information used in this report is self-reported, is not a required element of the application for public assistance and is not independently verified by staff. With the increased use of independent contractors, it is important to note that ACES data does not distinguish between employees and independent contractors who may self-identify as employees. Employer rankings are based on the average monthly number of employed persons associated with HCA medical clients in January and April 2020.

The creation of "households" for these analyses depends on assistance unit information in the ACES data system. From the perspective of creating household units from ACES data, limitations are likely to become more significant for measurement as more covered lives have medical eligibility determined outside of the ACES data system.

The tables report the number of employed Washington Apple Health (Medicaid) clients and nonclients with covered Dependents, and the associated "member months" by type of coverage. Coverage type was determined based on ProviderOne Recipient Aid Category (RAC) codes.

*The Family Medical / Pregnant Women coverage group* includes persons receiving TANF and related "classic" Medicaid medical coverage, as well as persons enrolled in Medicaid coverage for low-income pregnant women.

*The Apple Health for Kids program* provides medical coverage to children in families that do not meet Temporary Assistance for Needy Families (TANF) eligibility criteria but have household income below 200 percent of the Federal Poverty Guideline (FPL) through Medicaid funding, 300 percent of FPL through the Children's Health Insurance Program (CHIP) funding, and up to 300 percent of the FPL for non-citizen children through the Children's Health Program (CHP). This coverage group also includes a small number of children enrolled in Foster Care or Adoptions Support coverage.

*The New Adult coverage group* includes adults eligible for expanded Medicaid coverage under the Affordable Care Act.

*The Persons with Disabilities coverage group* includes persons enrolled in Medicaid Disabled or Blind coverage groups.



*The "Other" coverage group* includes a small number of persons receiving HCA medical coverage through programs for refugees and the elderly. Clients who received family planning coverage only were excluded from the analysis.

Employed non-client individuals with dependents with Washington Apple Health (Medicaid) coverage were counted if they were part of a household with at least one person who received Washington Apple Health (Medicaid) coverage. To be counted, the employed person had to be identified as the head of household, spouse, or unmarried co-parent of a child in common with the head of household.

Counts of employed clients or non-client individuals with dependents with Washington Apple Health (Medicaid) coverage were associated with a single "primary employer" in each month. The vast majority of employed clients or non-client individuals with dependents with Washington Apple Health (Medicaid) coverage had a single employer in the quarter. In cases where the person had more than one employer in the quarter, the primary employer was defined to be the employer from whom the person received the greatest earnings.

To create an unduplicated count of member months and expenditures associated with employed persons, in the cases where a dependent was associated with more than one employed person, we associated the dependent with the person who had the highest earnings. For both the aggregate and by-firm data tables, per-member per-month Washington Apple Health (Medicaid) expenditure estimates were based on per capita estimates for CY 2019. Per-member per-month mental health and substance use disorder service expenditure estimates were based on statewide average Behavioral Health Organization (BHO) capitation rates for CY 2019.
