Department of Social and Health Services, Economic Services Administration, Division of Child Support Agency: Subject of possible rule making: The Division of Child Support (DCS) is proposing to amend or add new sections in Chapter 388-14A WAC to implement SHB 1416 as enacted during the 2021 Legislative Session (Chapter 168, Laws of 2021). SHB 1416 establishes a requirement that insurance companies report claim settlements to DCS, which gives DCS time to intercept settlements and apply the funds to unpaid child support debts.

Statutes authorizing the agency to adopt rules on this subject: RCW 26.23.110, 34.05.220, 74.08.090, 74.20A.055, SHB 1416, Chapter 168, Laws of 2021, (codification pending)...
